 - For Each Additional Hour – Add \$100 to Minimum Charge/Add \$25 per bartender fee
- Last Call – on the half of the last hour

Specialty drinks, i.e., Long Island Iced Teas and frozen drinks, are not available at Cash or Host Bars. Any special requests for specialty cocktails or for liquors not noted in the menu must be coordinated in advance with Catering Manager and Hotel Beverage Manager.

All bar packages must be accompanied by food purchase.

Host Bar: The beverage service is paid entirely by the Host. Taxable service charge, state and local taxes will be added to the final bill.

Cash Bar: All beverages are paid at time of purchase at cash bar prices by the individual guests of the event; cash bar prices include all state and local taxes. Bartenders are not allowed to run tabs.

Bartenders: The Holiday Inn Bolingbrook will provide Bartenders for both Cash and Host bars. If bar sales do not reach \$250 per bartender, host will be responsible for the balance.

Pricing: Pricing is established by the Holiday Inn Bolingbrook in accordance with local liquor ordinances and taxation rates and may change without notice due to market conditions. Firm prices will be quoted 90 days prior to function date.

Beverage Rules: The Holiday Inn Bolingbrook reserves the right to refuse service to any person(s) deemed unsafe. Must be 21 to consume alcohol.

No outside alcoholic beverages may be brought into the Banquet Facilities at the Holiday Inn Bolingbrook.

The location of all host or cash bars will be at the discretion of the Holiday Inn Bolingbrook. The Holiday Inn Bolingbrook is the sole alcoholic beverage licensee on the Hotel's premises. It is subject to the regulations of the State Alcoholic Beverage Control Commission and violations of these regulations may jeopardize the Holiday Inn Bolingbrook's license. Hotel policies prevent the service of alcoholic beverages not purchased from or regulated by the Hotel. The Holiday Inn Bolingbrook reserves the right to decline service of alcohol for the safety of our guests.
